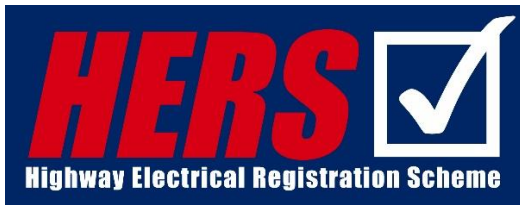

Notes:

- Trainers will be approved for defined courses / modules
- The annual registration fee will include an initial desktop assessment of each trainer to ensure they meet the appropriate requirements and are eligible for registration. If the desktop assessment does not satisfy the assessor a site visit will be required at the costs shown above.
- The registration of Approved Trainers is for a maximum period of 12 months and unless re-registration is actioned by the Approved Trainer / Approved Training Organisation it will expire. In order to maintain registration, Approved Trainer / Approved Training Organisation it will expire. In order to maintain registration, Approved Trainers will be required to have evidence of ongoing CPD and attend an up-dating seminar, which would usually be held annually.
- Reference to the Requirements for Approved Training Organisations and Approved Trainers part 4.9 for centre auditing of 4 or more Trainers.
- The Apprenticeship course delivery fee only applies to centres that are not delivering training within the sector and claiming individual learner certificates.



Approved PPA Centre Fees

Centre certification for 2021 will be issued on the receipt of payment from 1st January 2021.

The annual cost of £1150.00 will cover the following areas:

- Initial Centre Approval
- Annual Licence Fee
- Review and approval of centre assessors
- Development of moderation and marking systems
- Moderation of Learner assessments
- Annual PPA centre meeting

An additional charge of £620 will apply under following conditions;

- Additional approval visits
- Investigations as a result of whistle blowing or allegation of maladministration, practice

PPA Certification: Any changes to issued certificates will be completed for a charge of £25.00

You are reminded that you can charge up to a maximum of £175 per learner, with a maximum number of learners per day of 4. This charge excludes the centre day rate which includes travel and other associated costs.

Where fees have not been received and certificate issued, PPA assessments will not be permitted.
